**Cohen & Steers, Inc. to Report Second Quarter 2009 Results on  
July 22, 2009; Announces June 30, 2009 Assets Under Management**

New York, NY, July 13, 2009—Cohen & Steers, Inc. (NYSE:CNS) announced that it expects to release second quarter 2009 financial results after the market closes on Wednesday, July 22, 2009.
